We use a strategy of international presence and concern that supports local initiatives and contributes to developing a culture of peace and justice. We act on request of local non-violent groups working for human rights and social change in regions where there is oppression and conflict.

**COLOMBIA PROJECT**  
 Twenty-four international volunteers accompanied 24 organizations, two human rights defenders, and one community, working on a range of issues, from natural resources protection to forced disappearances. Volunteers are based in Bogotá, Barrancabermeja and Urabá. The project provided 697 days of accompaniment, held 438 visits and meetings with human rights defenders to provide moral support and practical advice around their protection needs, and delivered 43 workshops on protective strategies and/or reconstruction of the social fabric with 20 organisations, attended by 668 participants. The project met local, regional and national authorities 82 times; held 98 meetings with the diplomatic corps, the UN, other NGOs and international coalitions and networks; and met with civil society and church-based organisations 97 times. The project also held 248 meetings at an international level (Europe and North America).

**MEXICO PROJECT**  
 Ten international volunteers, based in Mexico City, Oaxaca and Chihuahua, accompanied 66 times defenders working on impunity, upholding indigenous rights and environmental protection, having impact over 14 accompanied organizations. The focus of the project in 2015 was to strengthen and widen the work of the current teams, both in Chihuahua City and Oaxaca City, in order to offer protective accompaniment to human rights defenders and also to provide them with the best tools in security and advocacy. The Mexico Project has been present in 96 events as dialogue spaces and demonstrations, held 111 meetings with Mexican authorities, 29 with diplomatic corps, and 63 with representatives of Ministries of Foreign Affairs and other governmental actors on the European Union and the UN. The project delivered 25 workshops on protective strategies and security for 7 organisations reaching 102 Human Rights defenders. PBI Mexico also facilitated 2 Trainer for Trainers workshops in Chihuahua, Mexico City and Oaxaca, in which 6 organizations participated.

**GUATEMALA PROJECT**  
 Eight international volunteers accompanied 82 defenders working on the environment and land rights, impunity and globalisation. Volunteers are based in Guatemala City and travel to other areas of the country. The Guatemala Project provided 182 days of accompaniment, held 148 visits and meetings with defenders to provide moral support and practical advice around their protection needs and facilitated four workshops on protective strategies (two only for women human rights defenders) for 115 defenders. The project also monitored 24 demonstrations. The project met local, regional and national authorities 64 times and held 91 meetings with the diplomatic corps, the UN, other NGOs and international coalitions and networks.
