PBI works to open a space for peace in which conflicts can be dealt with non-violently. We use a strategy of international presence and concern that supports local initiatives and contributes to developing a culture of peace and justice. We act on request of local non-violent groups working for human rights and social change in regions where there is oppression and conflict.

COLOMBIA PROJECT - Thirty-five international volunteers accompanied 18 organizations, human rights defenders, and communities, working on a range of issues, from natural resources protection to forced disappearances. Volunteers are based in Bogotá, Barrancabermeja and Urabá. The project provided 259 accompaniment, 43 international observation actions, held 362 visits and meetings with human rights defenders to provide moral support and practical advice around their protection needs, and delivered 41 workshops on protective strategies and/or reconstruction of the social fabric, attended by 1090 participants. The project organised 75 advocacy meetings on national level and held 329 meetings on international level, among others with diplomatic corps, the UN, other NGOs and international coalitions and networks; civil society and church-based organizations. Nine speaker tours were organized.

4b (Code:) (Expenses \$ **364,385** including grants of \$ **2,183**) (Revenue \$ **454,164**)

GUATEMALA PROJECT - A team of ten international volunteers accompanied 227 defenders working on the environment and land rights, impunity and globalisation. Volunteers are based in Guatemala City and travel to other areas of the country. The Guatemala Project provided 416 days of accompaniment, held 97 visits and meetings with defenders to provide moral support and practical advice around their protection needs and facilitated six workshops on protective strategies (two only for women human rights defenders) for 190 defenders. The project also monitored 14 demonstrations and 4 speaker tours in Europe and United States were organized. The project met local, regional and national authorities 70 times and held 74 meetings with the diplomatic corps, the UN, other NGOs and international coalitions and networks.

4c (Code:) (Expenses \$ **378,167** including grants of \$ **3,360**) (Revenue \$ **457,999**)

HONDURAS PROJECT - 14 international volunteers carried out 120 accompaniments to 7 organizations or human right defenders (HRDs) in Honduras working on land and environmental rights, indigenous rights, women's rights, rights to freedom of expression and association, and LGBTQ rights. PBI Honduras directly accompanied 113 HRDs (around 50% were women). The number of indirect beneficiaries - those supported or advised by the HRDs we accompany - was around 28,500. Our accompaniment work extended to several departments including Tegucigalpa, La Paz, Yoro, Atlántica, Cortés, Olancho, Comayagua and Santa Bárbara. Volunteers accompanied defenders, observed civil society activities, met with local authorities and visited communities and organisation's offices. PBI Honduras held 27 meetings with Honduran civil society organisations, 46 with Honduran authorities and 56 meetings with actors of the international community, including diplomatic corps, UN, EU, foreign ministries, parliamentarians and international NGOs. In addition, PBI Honduras organised two international speaking tours of accompanied defenders, who visited several European countries. The Honduras Project continued to consolidate its capacity building programme, facilitating 14 security and protection workshops to 252 HRDs (94 women). PBI Honduras also carried out 6 follow up visit to participants of previous workshops to check and support them in their application of security measures and plans.
